

2024 Spice World 75th Anniversary Sweepstakes Official Rules

NO PURCHASE NECESSARY TO ENTER OR WIN. A purchase does not increase your chances of winning. Participation in the 2024 Spice World Recipe 75th Anniversary Sweepstakes (“Sweepstakes”) constitutes participant’s full and unconditional agreement to and acceptance of these Official Rules. **THIS SWEEPSTAKES IS IN NO WAY SPONSORED, ENDORSED OR ADMINISTERED BY, OR ASSOCIATED WITH ANY SOCIAL MEDIA PLATFORM INCLUDING WITHOUT LIMITATION FACEBOOK OR INSTAGRAM FROM META (“SOCIAL MEDIA PLATFORM(S)”)**.

Sweepstakes Period: The Sweepstakes begins at 12:00:01 AM Eastern Time on May 28, 2024 and ends at 11:59:59 PM Eastern Time on August 11, 2024 (“Sweepstakes Period”).

Sponsor: The Sweepstakes is sponsored by Spice World, Inc. (“Sponsor”).

Eligibility: The Sweepstakes is open to natural persons 18 years of age and older who are legal residents of the 50 United States or Washington, DC. (“Participants”). Employees, officers, and directors of Sponsor, and all of its respective parents, subsidiaries, members, divisions, affiliates, advertising, promotion, and fulfillment agencies (“Sponsor and Promotion Parties”), and those individuals who are immediate family members of Sponsor and Promotion Parties, or persons living in the same household as Sponsor and Promotion Parties, are not eligible to participate in the Sweepstakes. “Immediate family” means parents, siblings, children and spouse. Sponsor reserves the right to verify the eligibility of winners. Void where prohibited. All federal, state, and local laws and regulations apply.

How to Enter: To enter, visit Sponsor’s Sweepstakes landing page available here (the “Landing Page”) and vote for your favorite regional dish: www.spiceworldinc.com/75th-anniversary (each an “Entry”). Limit one (1) Entry per participant per week during the Sweepstakes period, for up to ten (10) total Entries into the Sweepstakes. The geographic region and corresponding regional dishes featured on the Landing Page and eligible for voting will change each week.

Entries will not be deemed valid for the Sweepstakes unless they: (a) meet the requirements set forth above; (b) comply with the rules of the Sweepstakes; and (c) do not infringe, misappropriate or violate the rights of any third party. Entries that are not received by Sponsor for any reason will not be eligible and will be disqualified. Automated or bulk entries or entries submitted by third parties will be disqualified. Incomplete, illegible, corrupted or untimely entries are void and will be disqualified. Multiple participants are not permitted to share the same email address. Sponsor is not responsible for lost, misdirected, false, corrupted, illegible or late entries. Sponsor shall have the sole discretion to determine the validity of an Entry.

Prize Selection; Odds: Following the conclusion of the Sweepstakes Period, one (1) potential winner and one hundred (100) potential first prize winners will be selected at random by Sponsor from among all eligible Entries to receive the Prizes described below. The odds of winning the prizes depend on the number of eligible entries received during the Sweepstakes Period. The potential winners will be notified via email no later than August 16, 2024. The potential winners must respond within three (3) days of the original notification or may forfeit the prizes at Sponsor’s

discretion. In the event of a dispute over the identity of the selected Winner, the Winner will be deemed to be the Authorized Account Holder of the email address used at registration. "Authorized Account Holder" is defined as the natural person who is assigned to an email address by an Internet service provider, online service provider, or other organization (e.g., business, educational institution, etc.) that is responsible for assigning email addresses for the domain associated with the submitted email address. The potential winner is subject to verification before any prize will be awarded.
